This Agreement is between the Primary Member ("Member") and The Gun Range San Diego (TGRSD), or any third party company engaged by GRSD for the purpose of the processing of payments by Member (TGRSD) in relation to recurring charges to Member's account as designated in this Agreement. All charges shall be processed to the Credit Card designated by Member herein ("Billing Method"). Any account more than 5 days past due will be charged a \$10.00 late fee unless otherwise stated herein. Any unsuccessful scheduled electronic transaction is subject to a \$10.00 processing fee. TGRSD is not responsible for any bank fees incurred by Member. TGRSD has the sole right to modify any payment due date and to resubmit returned or declined items (plus applicable fees) without prior notice. Customer shall notify TGRSD in writing of any change in the Billing Method desired by Member. Only those Billing Methods specified in this Agreement shall be permitted. If the Billing Method is modified during the term of this Agreement, resulting in a missed or increased payment, the payment amount may be adjusted accordingly.

I authorize verification of this information and release all concerned from any liability in connection therewith. I hereby apply for membership at The Gun Range San Diego and have read and understand the qualifications of membership, including the payment requirements. I agree to abide by TGRSD's bylaws, range rules and adhere to its code of ethics. Membership will be granted, and may be revoked, at the sole discretion of TGRSD, with or without cause. I certify as follows: (1) that I am not and have never been the subject of a criminal or any other proceeding that prevents me from legally owning, handling or possessing firearms under California or Federal law; (2) that I can lawfully own, handle and possess a firearm; and, (3) that all information given in this Application is true and correct to the best of my knowledge.
